



Campus Outreach Grant Application & Guidelines

The Presbytery of Lake Erie provides grants to encourage congregations to develop ministries that cultivate relationships with local schools—primary, secondary, colleges, universities, trade, and vocational schools—and share the love of Jesus Christ with students. Periods of education and training can be especially formative and unsettled times in which the Church can be partners in the journey, providing support, encouragement, and a sense of belonging as students discover their sense of identity, community, and vocation. Our hope is that by encouraging congregations to build relationships with and within schools in their community that they will be “light and salt” (Matthew 5:13-16) for students and faculty, bearing witness to the unconditional and transformative love of Jesus Christ.

Our guidelines, therefore, will be as follows:

1. Applicants must be congregations in Lake Erie Presbytery.
2. Proposed ministries must be with an educational institution within the congregation’s municipality.
3. Applicants who receive funds will be expected to share the outcomes of their ministry and how the grant has directly benefited that ministry with the presbytery. This is spelled out on the feedback form at the end of this packet. Failure to do so will forfeit any opportunity for renewal of grant funds.
4. Grant requests will be given at a maximum of \$500/congregation. The congregation must give specific details about how the grant funds will be spent and give reasoning for how it will benefit the ministry.
